1. Thaha Municipality has allocated funds towards the cost of below mentioned works and intends to apply part of the funds to cover eligible payments under the Contract for below mentioned works. Bidding is open to all eligible as per Section V of bidding document..
2. Thaha Municipality invites electronic bids from eligible bidders for the construction of below mentioned works under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs.12,26,00,000.00
 - Minimum Work experience of similar size and nature: At least 1 contract within last 10 years each with a value of at least NRs.13,08,00,000.00
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes through electronic bids only, one containing (i) the Technical Bid and the other (ii) the Price Bid
 4. Eligible Bidders may visit PPMO e-GP system www.bolpatra.gov.np/egp to obtain further information and inspect the Bidding Documents.
 5. Bidder shall submit their bid electronically & download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Internal Revenue Account as specified below .

6. Pre-bid meeting shall be held at Thaha Municipality Office at 05/01/2021 (21/09/2077) at 14:00 hrs.
7. Electronic bids must be submitted to the office Thaha Municipality through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 noon on 14/01/2021 (01/10/2077). Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hrs on 14/01/2021 (01/10/2077) at the office of Thaha Municipality. Bids must be valid for a period of 120 days after bid opening and must be accompanied by scanned copy of the bid security in pdf format amounting to a minimum of 41,00,000.00, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
