- 7. Bids shall be opened in presence of Bidders' representatives who choose to attend on 14:00hrs 2076/02/17at the office of Thaha Municipality Office,Indrayanichaur,Makawanpur. Bids must be valid for a period of 90days counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum as mentioned in table below which shall be valid for minimum 30 days beyond the bid validity period.

8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
